 - 1. Finance Committee's Recommendation on a potential CD for investment purposes

 - The committee suggested to place \$250,000 from our operating account into a CD for 3 months and analyze growth or loss rates compared to LAMP.

a. Director

- Director provided professional development on open enrollment guidelines and procedures.
- We currently have 213 applicants on our waiting list.
- New BCA scholars for the 2022 2023 school year have been informed of their place on the waiting list as of Monday, February 7.
- The census report was discussed.
- Board to approve keeping additional paraprofessional on staff roster.

- A daily count is documented on positive COVID cases on campus and inputted onto the state portal.
- A request was made to provide the board with trending data on COVID cases at BCA.
- A discussion was had on the steps of sending a scholar home because of close contact to a COVID positive scholar on campus.
- Thibodaux Regional Medical Center (TRMC) is interested in becoming a educational supporter of BCA.
 - TRMC would donate \$10,000 for three years in agreement to display the TRMC logo on campus.
 - o TRMC is interested in donated playground equipment for the new campus.
 - A discussion was held on how to proceed with TRMC donation. Board agrees to display TRMC logo on the wall of honor once the new school open. The nurse's office is open for naming rights beginning at \$30,000.
 - We have three sponsors at the \$10,000 level for the Bash
 - The Director made it clear that the BCA Bash is specifically designed to raise money for the new school gymnasium.
