We do however fall into the higher achieving charter schools which according to the article have more difficulty filling the economically disadvantaged enrollment requirements.

 - For the 2023-24 school year, our goal is projected to be 55.8% of scholars who are economically disadvantage. We are currently at 40.5% of scholars who are economically disadvantage and we continue to increasing.
